

#MYBISSELLHOME Terms & Conditions

Information on how to enter forms part of the terms of entry.

Entry into the competition is deemed acceptance of these terms and conditions.

1. The Promoter is BISSELL (Australia) Pty Ltd (ABN 29 125 769 422) of 42 Rocco Drive, Scoresby, VIC 3179 ("BISSELL Australia").

2. Entry is only open to Australian and New Zealand residents who are registered members of Instagram. Entry is not open to employees of BISSELL Australia or affiliated companies, agents, wholesalers or retailers or the immediate families of such employees or those living in the same household of such employees.

3. The competition commences on 01 June 2019 at 9am AEDT and concludes on 31 December 2019 at 11.59pm AEST ("Promotional Period").
